Home Occupation Regulations

HOME OCCUPATIONS: A home occupation shall be subject to review and approval of the Community and Economic Development Department and the following standards pursuant to Sections §154.004 and §154.061 of the Tipp City Zoning Code:

- Incidental in nature:** The home occupation shall be clearly incidental and secondary to the residential use of the building and shall be confined to no more than twenty-five (25) percent of the total floor area of any one story of the dwelling.
- Location:** A home occupation shall be conducted entirely within the principal dwelling used as a residence.
- No change to character of dwelling:** There shall be any change in the outside appearance of the building or premises, or other visible evidence of the conduct of such home occupation.
- No additions:** There shall not be any structural additions, enlargements, or exterior alterations changing the residential appearance to a business appearance.
- Entrances:** No additional and separate entrance incongruent with the residential structural design shall be constructed for the purpose of conducting the home occupation.
- Parking:** No provision for extra off-street parking or loading facilities, other than the requirements and permitted facilities of the zoning district shall be permitted.
- Employees:** The operator conducting the home occupation shall be the sole entrepreneur, and shall not employ any other person other than a member of the immediate family residing on the premises.
- Occupational license:** A home occupation shall not require a state or local license and/or inspection.

9. **Advertising:** No external advertising except for one non-animated, non-illuminated, non-flashing announcement plate, indicating not more than the name and address of the resident. Said plate shall be attached flat against the wall of the residence and shall not exceed one square foot in total area.
10. **On-premise storage/sales:** No stock in trade or commodities, other than those prepared, produced, or created on the premises by the operator of the home occupation, shall be kept or sold on the premises
11. **No occupation** shall be conducted or equipment or process associated with such occupation used which creates excessive noise, vibration, glare, fumes, odors, dust, smoke or electrical interference.
12. **No display of products:** There shall be no display of goods or external evidence of the home occupation.
13. **No more than one commercial vehicle:** One commercial vehicle having empty weight of less than 10,000 pounds and not more than 7 feet in height may be parked on any lot in a residential district on a driveway that is permanently hard-surfaced.
