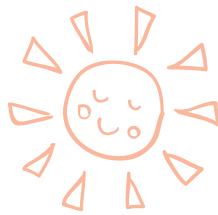

Utility Payments

Never be late with your Utility payment again. Tipp City Utilities offers Automatic Deduction from a bank account. The deduction occurs the 10th of every month or the first business day after the 10th if it falls on a weekend or holiday. Applications to participate in the Automatic Deduction program are located on the City's website www.tippcityohio.gov, "Services," "UTILITIES," "Payment Options" and then click on "autoduction form (PDF)," or use the form printed on the back of this issue of *Tippecanews*. To enroll, complete and return the form along with a voided check to the Utility Billing Department. ●

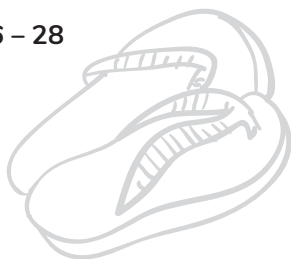
Caregivers may be included on a family pass when designated as one of the primary named adults on the family pass, is at

Shelter Reservations

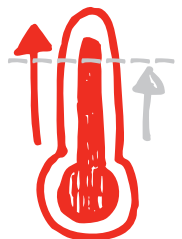
Whether you are looking for a place to hold a baby shower or graduation party, City Park and Kyle Park have shelters available for your special event. City Park features the historic Roundhouse and can seat 60 people. The Roundhouse can be rented for the entire day (7 am – 11 pm) to Tipp City residents for \$80. Also located in City Park are open air shelters which are available on a first-come, first-served basis and do not require a rental fee.

Kyle Park is the home to three shelters including the Rotary Pavilion, the Kyle Sports Pavilion and the Timmer Pavilion. The Rotary Pavilion is available at no cost on a first-come, first-served basis. Both the Kyle Sports Pavilion and the Timmer Pavilion rent to Tipp City residents for \$50 for the entire day (7 am – 11 pm). Both the Kyle Sports Pavilion and the Timmer Pavilion offer 8 picnic tables and a grill.

If you are interested in renting a shelter or need additional information, contact Dawn Gross. She can be reached by calling (937) 667-6350. Rentals begin the first Monday in March. ●

EFFICIENCY TIP

Using a humidifier in the winter can actually save you money. People require a higher temperature to remain comfortable in dry air than they do in humid air. Placing an energy-efficient humidifier in your living space during the winter months keeps the air from being as dry, which means you won't need the heat cranked as high to feel warm. ●





Did You Know?

Monthly utility bills can be emailed. Simply go to www.tippcityohio.gov, click on "Pay/View Utility Bill," create a login with the information from your most recent utility bill (make sure to use the *'s in your account # and type the name in all capital letters exactly as it appears on your utility bill in the field labeled "NAME") and select e-mail as your preference. ●

Automatic Utilities Payment Deduction Program

FREE – No Fee to Participate

Tip City Utilities offers Automatic Deduction from a bank account.

The deduction occurs on the 10th of the month. You will still receive your monthly bill as you currently do whether mail or e-mail; it will simply state "Auto Deduct to Occur on the 10th." If you are interested in signing up for Automatic Deduction, please **accurately complete, sign and returned this form to the Utility Department** in order for the deduction to begin. Please include a **voided check** if the deduction is to come from a checking account.

I understand that this authorization will be in effect until I notify Tipp City Municipal Utilities in writing that I no longer desire this service, allowing it reasonable time to act on my notification. I also understand that if corrections in the debit amount are necessary, it may involve an adjustment (credit or debit) to my account.

I have the right to stop payment of a debit entry by notifying my financial institution before the account is charged. If an erroneous debit entry is charged against my account, I have the right to have the amount of the entry credited to my account by my financial institution, if it is within (15) calendar days following the date on which I was sent a statement of account or a written notice of such entry or 45 days after posting, whichever occurs first. I must give my financial institution a written notice identifying the entry, stating that it is in error and requesting credit back to my account.
