Utility Payments

Never be late with your Utility payment again. Tipp City Utilities offers Automatic Deduction from a bank account. The deduction occurs the 10th of every month or the first business day after the 10th if it falls on a weekend or holiday. Applications to participate in the Automatic Deduction program are located on the City's website www.tippcityohio.gov, "Services," "UTILITIES," "Payment Options" and then click on "autoduction form (PDF)." To enroll, complete and return the form along with a voided check to the Utility Billing Department. ●

Did You Know?

Monthly utility bills can be emailed. Simply go to www.tippcityohio.gov, click on "Pay/View Utility Bill," create a login with the information from your most recent utility bill (make sure to use the *'s in your account # and type the name in all capital letters exactly as it appears on your utility bill in the field labeled "NAME") and select e-mail as your preference. ●

Shelter Reservations

Whether you are looking for a place to hold a baby shower or graduation party, City Park and Kyle Park have shelters available for your special event. City Park features the historic Roundhouse and can seat 60 people. The Roundhouse can be rented for the entire day (7 am - 11 pm) to Tipp City residents for \$80. Also located in City Park are open air shelters which are available on a first-come, first-served basis and do not require a rental fee.

Kyle Park is the home to three shelters including the Rotary Pavilion, the Kyle Sports Pavilion and the Timmer Pavilion. The Rotary Pavilion is available at no cost on a first-come, first-served basis. Both the Kyle Sports Pavilion and the Timmer Pavilion rent to Tipp City residents for \$50 for the entire day (7 am - 11 pm). Both the Kyle Sports Pavilion and the Timmer Pavilion offer 8 picnic tables and a grill.

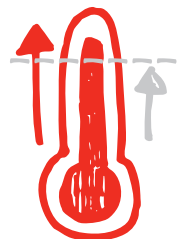
Appointments to Boards and Commissions

EFFICIENCY TIP

Snow Reminders and Information

With the eventual return of snow, Tipp City residents are reminded of the following guidelines regarding snow and ice removal. The Street Department asks residents to use the following guidelines for a safe winter season.

- If the City experiences a snow or ice storm, citizens should remove all vehicles from the street to allow for more efficient snow plowing.
- Please do not blow or shovel snow into the street.
- Trash cans and recycling bins should be placed in the curb lawn as not to interfere with snow removal.
- It is the citizen's responsibility to clear snow from the sidewalk and in front of their mailbox. It is not possible to clear these areas with snow plows.

In the interest of clearing streets in a manner maintaining safety/service vehicle traffic and public travel, the following schedule will be completed by snow removal crews for plowing and/or salting:

FIRST PRIORITY

- Main Street
- Hyatt Street
- Third Street
- South First Street
- East and West Kessler-Cowlesville Road
- Evanston Road
- County Road 25A
- Donn Davis Way
- School Areas

SECOND PRIORITY

CONNECTERS: Stonecress Dr., Beechwood, Brookmere, Tyler, Sycamore Woods Dr., Hampton Woods Dr., Barbara Dr., York Meadows Dr., Hunters Ridge Dr., Park Ave, Parkwood, Broadway (1st to Hyatt) South Fifth, Dow St. at Broadway School, Westedge, Garber Dr., Hathaway Trail, Tippecanoe, Manchester Dr., Woodlawn Dr., Commerce Park Dr., Kina, Weller, Harmony, Winston, Chevington Chase, Stonehenge, Copperfield, & Rosewood Creek Dr.
